

HUNTING PERMIT – TUSCARORA SCOUT RESERVATION

Camp Tuscarora is a youth training and camping area. For the safety of all Scouts and Scouters, extreme caution must be exercised by all hunters at all times. Hunting at Tuscarora is a privilege extended to you in exchange for your generous donation. This privilege can be revoked at any time, without refund. The Rules below must be strictly adhered to all times. The Camp Ranger has final say in all matters regarding hunting on this property. Our goal is to provide you with the best hunting experience possible. We will do our best to resolve any issue or problems that may occur.

1. Hunters must have a NYS Big Game license and abide by state and local regulations. The license must be presented at time of permit issuance. Hunter need not be present for permit issuance.
2. All hunters must complete a Hunting Permit and a Hold Harmless Agreement. Each hunter must carry the permit at all times while hunting on Scout property. A parking permit will be provided and must be displayed on your dashboard at all times when hunting on Camp Property. Maps available upon request.
3. The following dates have been established for the 2016 Tuscarora Hunting Season:
 - A. 16-24 November (Camp is closed to all other activities)
 - B. 25-29 November (**Hunting ends at noon on 29 Nov – all hunters must vacate the property**)
 - C. 2-6 December (**Hunting ends at noon on 6 Dec - all hunters must vacate the property**)
4. **During the periods 25-29 Nov and 2-6 Dec only:**
 - A. No hunting is permitted in the Main Camp area – see map with designated NO HUNTING areas.
 - B. No Main Camp entry is permitted except on business, or prearranged with the Camp Ranger.
 - C. All hunters must vacate the property at dusk – camping is not permitted.
5. **NO DRUGS OR INTOXICATING BEVERAGES** are allowed on Camp property. Hunters showing any signs of intoxication will lose their hunting privileges.
6. No fires are allowed on Camp property. All buildings and lean-to's are strictly off limits, unless rented.
7. ATV's are strictly prohibited.
8. **Tree stands are not permitted anywhere on the property – no exceptions. All tree stands will be removed immediately.**
9. Help keep our Camp clean; if you pack it in, pack it out. Gut piles must be buried.
10. Camping is permitted in approved camping areas. A camping permit must be obtained from the Scout Service Center or at Camp Tuscarora. No other camping is allowed. **ANYONE NOT CAMPING OVERNIGHT IN AN APPROVED AND RENTED SITE MUST LEAVE CAMP BY DARK! NO EXCEPTIONS!**
11. Please be courteous to our neighbors. All complaints will be investigated.
12. **SAFETY FIRST.** Hunters acting in an unsafe manner will be asked to leave.
13. **KNOW THE PROPERTY.** Hunters should be familiar with the camp boundaries and the location of camp buildings. No shots should be fired in the direction of camp buildings.
14. Hunting at Camp Tuscarora is a privilege, not a right. **ANY VIOLATION OF THESE RULES WILL RESULT IN THE FORFEITURE OF HUNTING PRIVILEGES.** There shall be no refunds.
