

BADEN-POWELL COUNCIL FEES AND RENTALS

The following facilities are available at the prices stated. **The Volunteer Committees of the Baden-Powell Council have determined that these fees are necessary to ensure the upkeep and continued existence of our Council Properties.** Reservations are made at the Scout Service Center, 2150 State Route 12, Binghamton, NY 13901. You may contact the Council Camping Secretary at 607-648-7888. Full fee plus any security deposit required must accompany all reservations. **Weekday pricing is ½ of the weekend fee, per weekday.** You must take away all trash generated except when renting the Dining Hall or complete facilities. Scout units may be requested to perform a 1 hour service project while at camp. (Note- this does not change the rental fees.)

Usage Agreements for Scout Units Only (Non-Scout Units see next Page)

Please Read, Complete and Sign

1. All persons/group must register with Campmaster or Ranger immediately upon entering camp. **Camp opens for check-in at 5:00pm on Friday evening and closes at 11:00am on Sunday.**
2. All Fees and Deposits must be prepaid at the Council Service Center prior to use of camp. Please bring receipt to verify payment.
3. Units using additional facilities beyond what was rented will be expected to pay. Rangers have authority to enforce this policy. (Note- Units cannot decide to do a service project instead of paying.) **A Scout is Trustworthy.**
4. Winter Units/Lean-to units are restricted to occupancy of 16 at Camp Barton (with additional tent camping, up to 48 at the lean-to site) and 32 at Tuscarora Winter Units, except for Council/District events. Electric heaters are not allowed.
5. Tent camping is strongly discouraged in Winter Units. The only exceptions are for Council/District events, to fulfill Youth Protection ratios, or for Merit Badge/Advancement reasons. (Except for District/Council events, Tent Camping is not allowed in Winter Unit 2 at Tuscarora.) Units wishing to tent camp in the winter should use Summer Units 1, 2, 3, and the Handicapped Accessible Site (Tuscarora Only).
6. All persons/groups must be checked out by Campmaster or Ranger and **leave camp by 11:00am Sunday.** *Units wishing to stay longer must make prior (at least 2 weeks) arrangements directly with Ranger.*
7. Damages: Any damage to camp property or equipment will be billed to the person(s) responsible for the damages. Some buildings require a damage deposit.
8. Security/Damage deposit will be refunded only after satisfactory inspection of the facilities/equipment used by the Camp Ranger. Refunds will be issued from the Council Service Center.
9. No Unit Leader/Unit member pets are allowed on camp property. Service animals are welcome.
10. Camp Ranger (or designee) is authorized to ask people to leave Camp who have violated regulations discussed herein. Rangers (or designee) have complete authority in Camps, as per the Scout Executive.
11. Dates are subject to written cancellation no less than 30 days in advance by Baden-Powell Council.
12. Traveling Scout Units must provide Tour Permits/Plans for Inspection at Check-In.
13. **Absolutely No Alcoholic beverages or illegal drugs are allowed on Scout property at any time.**
14. **No Smoking in buildings or in front of Scouts.**

3. Units using additional facilities beyond what was rented will be expected to pay. Rangers have authority to enforce this policy. (Note- Units cannot decide to do a service project instead of paying.)
4. Winter Units/Lean-to units are restricted to occupancy of 16 at Camp Barton (with additional tent camping, up to 48 at the lean-to site) and 32 at Tuscarora Winter Units, except for Council/District events. Electric heaters are not allowed.

7. Damages: Any damage to camp property or equipment will be billed to the person(s) responsible for the damages. Some buildings require a damage deposit. Refunds will be issued from the Council Service Center.
8. Security/Damage deposit will be refunded only after satisfactory inspection of the facilities/equipment used by the Camp Ranger.
9. No Unit Leader/Unit member pets are allowed on camp property. Service animals are welcome.
10. Camp Ranger (or designee) is authorized to ask people to leave Camp who have violated regulations discussed herein. Rangers (or designee) have complete authority in Camps, as per the Scout Executive.
11. Dates are subject to written cancellation no less than 30 days in advance by Baden-Powell Council.
