GENERAL INFORMATION AND INSTRUCTIONS:

- Applicants for camperships **MUST** be currently registered members of Scouting America. Applications for unregistered persons and applications without proper signatures will be returned.
- The Council Camping Committee is concerned about the individual needs and the Unit's individual evaluation of the Scout for whom this request is made.
- Generally, camperships are limited to no more than 40-50% of the activity cost. Each Scout, their family, and/or their Unit should provide a minimum of 50% of the activity cost.
- Camperships are not transferable, refundable and have no cash value.
- Applications must be submitted no later than April 1, 2025. Applications received after April 1st will be reviewed but may not be granted due to limited funds.
- All information in this application will be treated confidentially.
- The ninth part of the Scout Law is "A Scout is THRIFTY." A Scout works to pay their own way. The Council Camping Committee is very interested in what the Scout has done to assist their family in providing them with this camping experience. This is a character-building opportunity for the scout to learn the importance of being THRIFTY.
- Unit Endorsement is extremely valuable to the Council Camping Committee. Failure of the Unit to provide this endorsement may result in the application being denied or delayed until further information can be obtained.
